Inside this year's **Freedom Report**, you'll see what your commitment has made possible: victories across the nation and around the world. Some battles are now the victories behind us, while others continue — but you've been a driving force in every one. Together, we've stood boldly on the front lines of some of the most pivotal legal and constitutional conflicts of our time.

35 YEARS OF VICTORIES FOR YOU

This year is no exception



ELECTION INTEGRITY SAFEGUARDED

We believe voting is not just a constitutional right — it's a civil and sacred duty.

Ahead of the 2024 national elections, we fought aggressively to protect that right. Our legal team took action at every level: from state courts to the U.S. Supreme Court, on Capitol Hill, and through numerous FOIA lawsuits.

We secured key victories — keeping President Trump on the ballot in Colorado, helping remove ineligible voters from Virginia's rolls, and more.

Every step of the way, we defended your voice at the ballot box.

UNANIMOUS WIN FOR CHRISTIAN CHARITY AT U.S. SUPREME COURT

In a unanimous 9-0 decision, the U.S. Supreme Court ruled in favor of Catholic Charities in Wisconsin, reversing a state court decision that had stripped the charity's tax-exempt status for serving the poor — deeming the action “not typically religious.”

The ACLJ filed an amicus brief, arguing for stricter constitutional review under the First Amendment's Free Exercise Clause. The high

Court did indeed apply heightened review — the “strict scrutiny” standard — in reversing the Wisconsin Supreme Court and delivered a major win for religious liberty.

Other Incredible Victories in the Fight for Life and Freedom

- **Rights of parents and students AFFIRMED** — we successfully sued a Nevada school district after a child was forced to perform a pornographic monologue in class.



- **Justice SUSTAINED** — Muslim man who raped young Christian girl sentenced to life in prison after ACLJ affiliate in Pakistan took action.
- **VINDICATED** — a street preacher in Chicago who was wrongfully arrested for sharing the Gospel — his free speech and religious liberty protected.
- **Israel's interests DEFENDED** — as six of our clients, hostages after the October 7th attack by Hamas terrorists, were released.
- **President's Executive authority UPHELD** — tremendous victory against radical-Left attacks on President Trump and the conservative agenda.

MAJOR WIN — CRIMINAL CHARGES DISMISSED!

Thanks to your support, the ACLJ won a major free speech and religious liberty case for Zack and Lindsay Knotts.

They were peacefully advocating for unborn lives outside an Ohio abortion clinic using a

megaphone — an instrument considered indispensable for effective political speech by the U.S. Supreme Court — on a public sidewalk. Meanwhile, clinic escorts used louder whistles and kazoos and even made personal threats, yet only Zack Knotts was arrested and criminally charged.

On the day of the trial, with a packed courtroom watching and the ACLJ at Zack's defense, the prosecution dropped all charges.

Now, we're taking additional action. We've filed a federal lawsuit challenging the unconstitutional arrest and biased city ordinance that silences pro-life voices. This is a clear case of viewpoint discrimination — punishing speech based solely on its message. And as attacks on pro-life advocates increase, we're defending a myriad of clients and undertaking a growing caseload.

With your continued support, we're standing firm for life, liberty, and justice.

35 YEARS OF FIGHTING FOR LIFE

Bold wins in 2025 push us forward



For 35 years, the voice of the ACLJ has been unwavering for life. And, in this post-*Roe* era, the battle isn't over — it's intensified. From statehouses to federal courts, from city councils to hospital corridors, we're confronting a new wave of anti-life extremism and unconstitutional attacks. **Our commitment to life is as evident this year as it always has been.**

UPHOLDING PRO-LIFE SPEECH AND WORKERS' RIGHTS

- The ACLJ won a major conscience rights case for “Judy,” a nurse pressured to assist in abortions. The hospital reversed course, offering full accommodation and extended those rights to others.
- The ACLJ also defended five ultrasound technicians in New Mexico who were threatened with forced abortion participation ... and won!

VICTORY FOR PREGNANCY RESOURCE CENTERS

The abortion lobby manipulated its political allies in Massachusetts into initiating a state-

sponsored smear campaign designed to paint pro-life Pregnancy Resource Centers (PRCs) as dangerous and deceptive. They've labeled PRCs as “anti-abortion centers” and warn unsuspecting pregnant women of untrained staff, false information, and deceptive advertising, claiming PRCs pose a threat to their health and well-being.



Our legal team launched a multipronged legal campaign, including FOIA requests and filing a lawsuit against the Commonwealth of Massachusetts and the abortion industry to shut down these

unlawful smears, lies, and distortions about our PRC clients. We have already been to court and soundly defeated the defendants' first efforts to dismiss our complaint.

Along with taking legal action, we've launched a huge counter-campaign in an unprecedented and groundbreaking effort to combat the mass deception, defend pro-life pregnancy centers, and enable them to continue their lifesaving work without harassment or government interference.

FREE SPEECH WINS FOR PRO-LIFE ADVOCATES

In Kentucky, the ACLJ successfully challenged Louisville's unconstitutional buffer zone ordinance on behalf of two sidewalk counselors. This victory ensures that sidewalk counselors can continue offering prayer and support outside clinics without fear of unlawful government interference. We're preparing now for a similar victory in Carbondale, Illinois, where we've filed suit to strike down an unconstitutional ordinance targeting pro-life signs.



EXPOSING ANTI-LIFE EXTREMISM IN THE MILITARY AND GOVERNMENT

Using the Freedom of Information Act to uncover training documents, the ACLJ first exposed the U.S. Army for instructing trainees that Operation Rescue, pro-life groups, and "Choose Life" license plate owners are domestic terrorists. We then sent a letter to the Secretary of Defense Pete Hegseth to ensure an end to abortion propaganda in Army training. He issued an official statement in response to our letter, apologizing for the Army's misconduct.



ACLJ SECURES MAJOR SUPREME COURT WIN TO DEFUND PLANNED PARENTHOOD

We are honored to have played a pivotal role in a landmark Supreme Court decision that upholds state sovereignty and defunds abortion providers.

In *Medina v. Planned Parenthood*, the Court ruled 6-3 that individual Medicaid recipients cannot sue states for removing abortion providers like Planned Parenthood from their Medicaid programs.

This outcome directly reflects the arguments we made in multiple amicus briefs, urging the Court to preserve states' rights and reject the misuse of federal civil rights law by abortion advocates. The ruling affirms that only Congress — not activist courts — can authorize such lawsuits, closing a legal loophole long exploited by Planned Parenthood.

Thanks to the ACLJ's efforts *and your invaluable partnership*, states now have greater freedom to support life-affirming healthcare providers without fear of litigation from third-party activists.

We are now defending the Big Beautiful Bill's defunding of Planned Parenthood with more briefs in federal court.

Your freedoms secured, your faith preserved



For 35 years, the ACLJ has stood with people of faith — *members like you* — fighting for your right to live out your faith boldly and freely.

This year alone, our legal victories have protected pastors, poll workers, employees, and everyday believers from government overreach and religious discrimination across the country. These aren't just legal wins — they're *your* freedoms secured, *your* voice defended, and *your* faith preserved.

WORKPLACE WINS FOR FAITHFUL EMPLOYEES

The ACLJ secured religious accommodations for clients who faced threats because of their faith: a U.S. Postal Service employee, Walmart employees, and a TSA agent all received religious accommodations to attend church on Sundays — ensuring their right to



worship was fully protected.

VICTORIES FOR TEACHERS, STUDENTS, AND PRAYER IN SCHOOLS

When public school officials silenced Christian teachers and prohibited student prayer, the ACLJ fought back:

- When Staci Barber was told explicitly by her school's administration that she could not "pray in the presence of students" on the morning of a See You at the Pole event before school hours, we filed suit — and have secured a preliminary victory allowing her to pray as the case continues.



- We're now defending her rights on appeal.
- When students in Boise, Idaho, bowed their heads to pray at their school's flagpole, they were silenced — a shocking violation of their First Amendment rights. The ACLJ sprang into action, confronting the school and demanding written guarantees of no interference. Thanks to your support, students across Boise can continue to pray boldly and publicly.

STANDING TOGETHER FOR RELIGIOUS LIBERTY AT THE SUPREME COURT

We filed a vital amicus brief at the U.S. Supreme Court in defense of Gabriel Olivier, a street preacher who was criminally charged for sharing his faith near a public amphitheater — outside the city’s designated “protest zone.” After paying a fine, Olivier tried to challenge the city’s unconstitutional restriction on free speech, but the courts refused to even hear his case.

The ACLJ stepped in to urge the Supreme Court to correct this injustice. After we filed our amicus brief, the Supreme Court agreed to take the case, and Gabriel Olivier will get an opportunity to plead his case at the nation’s highest court.

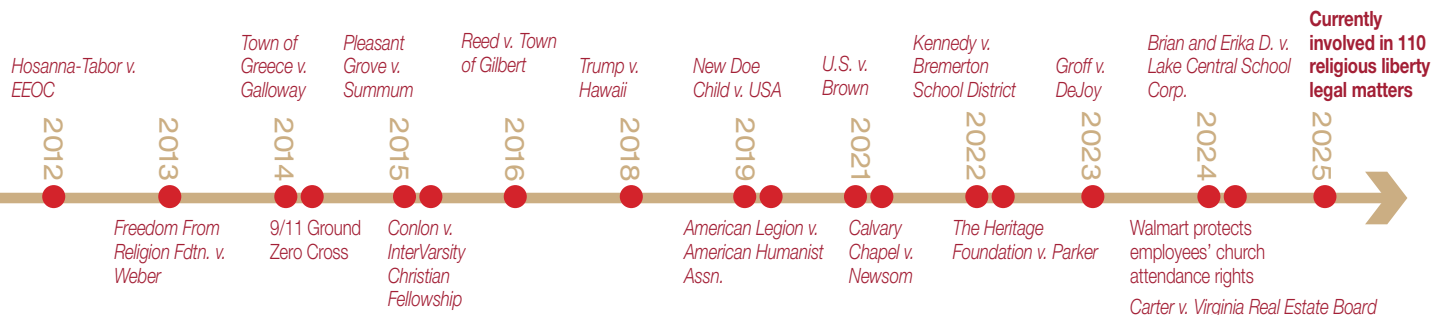
This case strikes at the heart of religious freedom and the right to be heard in court. If the lower court’s decision stands, it could shut the courthouse doors to countless Americans who face government overreach — especially those who, like Olivier, are simply trying to live out their faith.

Rooting out corruption until justice is served



For 35 years, the ACLJ has stood firm against government abuse. Today, this mission is more urgent than ever. Threats from the Deep State are growing ... and we're fighting back, defending the rule of law when others abandon it for political gain.

These aren't just legal battles; we're working to protect the freedom of every American, including you.

TAKING ACTION AGAINST LAWFARE AND POLITICAL TARGETING OF PRESIDENT TRUMP

The ACLJ filed a major amicus brief in a New York appellate court, challenging the \$350 million civil judgment against President Donald Trump. The brief argues that New York Attorney General Letitia James violated the First Amendment by using her office to retaliate against Trump for his political speech.

This case isn't about fraud — it's about weaponizing the legal system to silence a political opponent. No victims claimed harm, and no financial institutions reported losses. Yet, the AG pursued unprecedented penalties, driven by her campaign promise to “go after” Trump.

Our brief exposes this abuse of power and defends the principle that no American should be punished for their political views. This is part of a broader effort to stop the growing trend of politically motivated prosecutions aimed at silencing conservatives.

We will always stand up for the Constitution — and for the right of every citizen to speak freely without fear of government retaliation.

CHALLENGING BIDEN-ERA OVERREACH IN REGULATION AND SURVEILLANCE

The ACLJ has filed its third amicus brief in support of a constitutional challenge to the Corporate Transparency Act (CTA) — a law requiring millions of small businesses, nonprofits, and political groups to report sensitive ownership information to the federal government or face criminal penalties.

We argue that the CTA violates the First Amendment, exceeds Congress' authority, infringes on privacy rights, and enables political targeting. Government overreach must be defeated in court.

EXPOSING FBI ABUSE AND DEFENDING WHISTLEBLOWERS

We represent brave whistleblowers who have been stifled by the Deep State; we recently represented, and completely vindicated, FBI Special Agent Garret O'Boyle. O'Boyle was suspended for years for testifying to Congress about the FBI's anti-conservative, anti-Christian bias. The DOJ has since agreed to fully restore O'Boyle with back pay, benefits, damages, and his security clearance.

Joining a coalition of organizations, we sent a letter to House committees urging two key reforms to protect FBI whistleblowers:

1. **Equal Whistleblower Protections** — to extend the same legal protection to FBI employees that other Justice Department and federal law enforcement personnel receive.
2. **Review of Security Clearance Retaliation** — provide oversight to ensure constitutional rights are not violated.



"It is imperative that Congress act quickly to ensure meaningful whistleblower protections for heroic whistleblower agents like our clients who are following

the law in order to expose some of the worst government corruption we've ever seen. Without additional protections, the politicized bureaucracy will continue to weaponize the justice system against innocent Americans with impunity, silencing the only ones who can lawfully expose their abuses."

35 YEARS OF STANDING WITH ISRAEL

Truth over propaganda — law over lawfare — courage over cowardice



For 35 years, through every battle in the courtroom, at the United Nations (U.N.), and before Congress, ACLJ members like you have empowered a legal defense of Israel that is principled, powerful, and persistent. We will not stop. We will not back down. And we will not allow Israel to stand alone.

THE SUN NEVER SETS ON OUR CRITICAL WORK IN ISRAEL AND FOR JEWISH PEOPLE EVERYWHERE

Our team of lawyers on the ground in Jerusalem works *daily* to protect Israel's very right to exist. Whether or not threats to Israel's sovereignty are being covered in the news, it is *always* an issue.

ICC ARREST WARRANTS AGAINST ISRAELI LEADERS

After the International Criminal Court (ICC) announced arrest warrants for Prime Minister Netanyahu and former Defense Minister Gallant, the ACLJ immediately took action.

- Through our European affiliate (the ECLJ), we filed an amicus brief request before the pre-trial Chamber, arguing that the ICC has no jurisdiction over Israeli nationals.
- We also called on the U.S. Senate and President Biden to impose sanctions on the ICC for this outrageous political targeting.
- We sent legal letters to 38 non-member nations, urging them not to cooperate with the ICC and instead sanction the court for overstepping its authority.

EXPOSING U.N. LIES AND ANTISEMITIC REPORTS

The ACLJ submitted formal reports to expose false claims made by the United Nations, particularly allegations of “gender-based violence” by Israeli soldiers — without evidence — while ignoring verified Hamas atrocities.

HOLDING TERROR FUNDERS ACCOUNTABLE IN U.S. COURTS

The ACLJ filed a critical amicus brief at the U.S. Supreme Court, urging the Justices to allow Americans to sue the Palestinian Authority and Palestine Liberation Organization (PLO) under the Anti-Terrorism Act for their role in funding attacks that killed Americans. We helped secure a tremendous victory over the terrorists who attack Israeli and American citizens.

REPRESENTING ISRAELI HOSTAGES AND SECURING RELEASES

We represented multiple Israeli hostages held by Hamas, including two more clients who were freed earlier this year after nearly 500 days (some of that time spent in U.N.-run facilities).

From One Voice ... to a National Movement

A MISSION TO PROTECT RELIGIOUS LIBERTY & CONSTITUTIONAL RIGHTS.

In 1990, the ACLJ was founded with a mission to protect religious liberty and constitutional freedoms through strategic legal action.

A LANDMARK VICTORY FOR EQUAL ACCESS.

One of Jay Sekulow's first Supreme Court victories, Board of Education v. Mergens, overwhelmingly upheld the constitutionality of the

Equal Access Act, which requires public schools to allow student-initiated Bible clubs or prayer groups equal access to meet on campus.

DEFENDING RELIGIOUS VIEWPOINTS.

In Lamb's Chapel v. Center Moriches School District (1993), the ACLJ defended the right of a church to access public school facilities — a case



that reaffirmed how religious viewpoints cannot be excluded from public forums.

HIGH-IMPACT LEGAL ADVOCACY.

These early wins laid the foundation for decades of high-impact legal advocacy that would shape the national landscape on free speech, religious liberty, and the sanctity of life.

Defending the rights and dignity of God's people worldwide

From death row cases in Pakistan to torture survivors in Iran and U.N. reports exposing mass killings in Africa, it has been our 35-year mission to defend the rights and dignity of Christians suffering for their faith.

Our work is saving lives, defending families, and holding anti-Christian regimes accountable on the global stage.

DEFENDING CHRISTIANS ON DEATH ROW IN PAKISTAN

The Organization for Legal Aid (OLA), an affiliate of the ACLJ, is representing 26-year-old Christian Ahsan Masih, who faces a death sentence after allegedly sharing a “blasphemous” image

on social media. We are actively appealing his conviction and extending vital support to his family.

PREVENTING DEPORTATION OF PASTOR TORTURED IN IRAN

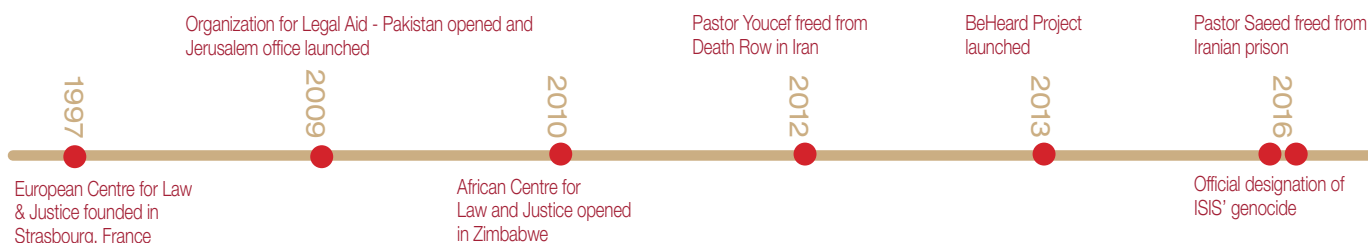
We filed at the U.N. in support of Pastor Mojtaba Ahmadi, an Iranian Christian previously tortured for his faith who, imprisoned on questionable charges, faced deportation from Turkey back to Iran. The ACLJ urged the United Nations to stop his forced return to danger.

The ACLJ submitted six formal reports to the

PERSECUTED CHRISTIANS

United Nations in one week alone documenting persecution of Christians in Pakistan, India, Turkey, and the Democratic Republic of the Congo (DRC) — including child abductions, forced conversions, and state inaction.

EXPOSING MASSACRES IN THE CONGO

Islamic extremists beheaded 70 Christians in the DRC in February 2025. One woman was beaten and stabbed to death while singing praises to God. We have taken a firm stance by addressing an official letter to the U.N. Human Rights Office of the High Commissioner and working to bring global attention to this atrocity.

SECURING JUSTICE FOR VICTIMS OF SEXUAL VIOLENCE AND MURDER

Our affiliate in Pakistan secured a life sentence for a Muslim man who raped a young Christian girl. In another case, we ensured that a murderer who killed a Christian woman during a robbery was convicted and his sentence upheld.

The ACLJ remains committed to protecting Christians worldwide from targeted violence and abuse.

Persecution of Christians Must End

In June, I personally delivered a message in front of the U.N. Human Rights Council (HRC) in Geneva to urge international intervention for suffering Christians in the Democratic Republic of the Congo (DRC) and all around the world. I traveled to Geneva to shine a light on the deadly violence and abuse being cruelly inflicted on innocent Christian men, women, and children.

The widespread targeted slaughter of our brothers and sisters in Christ in the Congo is reaching genocidal levels. As I told the global body:

“In February 2025, the ADF [Allied Democratic Forces], a terrorist group affiliated with the Islamic State, massacred 70 Christians in brutal attacks that targeted places of worship. These atrocities are part of a broader campaign of terror. Between January and February 2025, a child was sexually assaulted every 30 minutes, and over 7 million people are now internally displaced.”

These atrocities must be condemned by all nations, the perpetrators held to account, and God’s people protected. The ACLJ is strategically positioned to make a difference — in the DRC, Afghanistan, Nigeria, Pakistan, India, and elsewhere.

Our teams will never stop defending persecuted believers worldwide. Thank you for standing with us as we continue to shed light on the global persecution of Christians.
